

MAKING A DIFFERENCE BY BECOMING A MASTERY FOUNDATION

Sponsors make annual contributions to the Mastery Foundation of \$10,000 (\$15,000 for couples), \$25,000 or more. They play a pivotal role in financing the Mastery Foundation's work in empowering individuals and communities in their ministries, in the reconciliation and healing of divisions, and in creating new conversations and possibilities for the future. Our Sponsors truly extend the reach of the Mastery Foundation internationally — to Northern Ireland and to Israel.

For example, each \$10,000 invested in the Mastery Foundation funds:

- Five Protestant grass roots leaders and five Catholic grass roots leaders to attend our three-day reconciliation Intensive in Northern Ireland.
- Five Jewish Israelis and five Palestinian Israelis to participate in the reconciliation Intensive we are developing in Israel
- A leadership team to deliver a Community Empowerment Program in Northern Ireland or Israel.
- A scholarship funding a participant from the United States, Northern Ireland, or Israel for one year of the three-year curriculum of the School for Leadership.

Leadership Sponsors make a five-year commitment to sponsorship. **Legacy Investors** make a five year commitment as Sponsors at \$25,000 or more a year. This long-term support is critical in allowing the Foundation to be bold in its long term planning both domestically and internationally.

Regular and Leadership Sponsors are offered the opportunity to attend any Mastery Foundation program in the United States and one international program (attendance limited) each year they sponsor. Legacy Investors may attend more than one international program. Opportunities may include:

- A two-day Community Empowerment workshop in Northern Ireland
- A developmental Intensive in Israel
- A reconciliation Intensive in Northern Ireland.
- The three-day Making a Difference program in the United States or Northern Ireland

Attendance at these events is subject to limitations in numbers and includes requirements for your form of participation. In every case, sponsor participation makes a meaningful and positive impact on the event.


